



2012-2013 Referral Bonus Program

Dear Friends of Cincinnati Christian Schools,

To show our sincere gratitude to the people who promote CCS to their friends and families, we are offering the Referral Bonus Program again this year. Please take a moment to review this information and prayerfully consider whom you could invite to be a part of Christian education with a mission to equip, train and disciple students. **This year we offer \$640 to the referring family, church, or pre-school for each new family enrolled at CCS.** The bonus will be given in February, 2013. If the new student does not return for the second semester, no bonus will be given.

You may choose one of the following manners in which to receive your Referral Bonus:

1. Cash – You will receive a check from CCS in February, 2013.
2. Lower your 2nd Semester tuition payment by readjusting your FACTS payment.
3. Donate the Referral Bonus to the family that you referred.
4. Donate your Referral Bonus to our Financial Aid/Scholarship programs.
Need is determined by our Grant & Aid Assessment application administered by the FACTS program. We believe Christian education should be available to all Christian families, whose students meet or exceed our enrollment standards, regardless of family income.

5. Donate your Referral Bonus to your church or pre-school for their work in promoting our school. Partnerships developed with churches, pastors, and schools, is key to the success of Christian education at CCS.

6. Donate your Referral Bonus to a pastor or youth pastor to help send their children to CCS.
7. Donate your Referral Bonus to our daily operating fund. This fund is used to pay teachers and staff, pay utilities, property maintenance and for purchasing daily educational supplies.
